Granville Vance Public Health (GVPH) is currently accepting applications for a full-time **Community Development Specialist-I**. This position will coordinate and implement policy, systems, and environmental changes designed to improve systems of care for you th and their families in Granville and Vance counties. The position will serve as a Service Integration Consultant for North Carolina Integrated Care for Kids (NC InCK) model (Reference <u>https://ncinck.org</u>); supervise the Rights, Respect, Responsibility (3Rs) Program; and may have related and specific duties within the THRIVE grants/programs as we partner closely with local school systems.

The position will be responsible for coordinating and managing multiple programs, including:

- Facilitate cross-sector coordination among childcare serving and health agencies for youth with complex health needs or those at high risk of out-of-home placement
- Participate in weekly NC InCK Learning Collaborative with broader team of Services Integration Consultant to support the development of the process of service integration and of the NC InCK Model
- Provide consultation with the Family Navigator for each youth assigned to caseload; communicate and coordinate with the Family Navigator as needed to minimize fragmented care through appropriate service utilization.
- Document all activities in relevant electronic documentation systems as identified by NC InCK
- Work collaboratively and establish relationships with agencies in five target counties to serve youth
- Serve as the Healthy Communities grant manager and fulfill all program reporting requirements
- Manage funds for and procure all program-related materials
- Monitor quality and effectiveness of interventions to the population by setting measurable goal(s).
- Connect regularly with the Health Promotion & Wellness Team as well as local school systems in partnership.

**MINIMUM QUALIFICATIONS:** Minimum qualifications for this position are, graduation from a four-year college or university and at least three years of experience, preferably in a field related to the specific program assignment; or an equivalent combination of training and experience. Project management and grants management experience are preferred.

**COMPENSATION PACKAGE**: GVPH offers competitive benefits including paid group medical insurance, N.C. Local Government Employees Retirement System membership, thirteen paid holidays, and vacation and sick leave.
