Granville Vance Public Health is now accepting applications for the position of Public Health Foreign Language Interpreter II to work in our Public Health Clinics in Granville and Vance counties.

THE PRIMARY PURPOSE: This full-time position is responsible for providing Spanish interpreting services for Granville Vance Public Health Clinical Services and to assist staff in providing care to the Spanish-speaking population. The interpreter will ensure that all services, communications, documentation, etc., associated with a program are provided in the client's native language as mandated by law, program guidelines, or needs. The ideal candidate will provide verbal interpretation of all information shared between staff and clients/parents/caregivers, etc. The work of an interpreter involves translating all written materials and serving as a point of contact for clients. Interpreters may coordinate transportation, assist in arranging referrals to local services and resources; interpret test items, programmatic information, or results of evaluations; conduct interviews to obtain program or personal data and/or assist management in monitoring the accuracy of translating/interpreting services. Interpreters assist clients to ensure that appropriate services are determined, offered, received, or given.

MINIMUM QUALIFICATIONS: High school or General Educational Development (GED) diploma and two years of experience in interpreting and translating English and the required foreign language in a setting that requires a knowledge of the programs or service; or an equivalent combination of education and experience.

COMPENSATION PACKAGE: GVPH offers competitive benefits including paid group medical insurance, NC Local Government Employees Retirement System membership, thirteen paid holidays, two additional floating holidays, and vacation and sick leave.
